

Associate Membership Application

Any person or firm who does not produce or place hot mix asphalt pavement or liquid asphalt, but who is interested in promoting and advancing high standards in the use of hot mix is eligible for associate membership.

The associate membership was established by vote of our members in response to numerous inquiries from allied businesses regarding the availability of such membership.

The rights and privileges offered to members include the opportunity to:

- 1. Receive information and publications from the association office, including the monthly bulletin,
- 2. Be notified of and attend all meetings and seminars sponsored by the association,
- 3. Serve on appropriate committees,
- 4. Be listed as a member in the Texas Asphalt Pavement Association directory and on any other membership listing,
- 5. Participate in the exchange of ideas, information, and research to advance the quality of the product or industry.

Dues for associate membership have been set at \$1,000.00 per year. Membership shall have an annual renewal date of January each year. If not paid within 30 days of due date each year, the member is subject to expulsion from membership by the Board of Directors. An associate member expelled for nonpayment of dues may be reinstated by the Board of Directors, upon submission of an associate membership application form and a check in the amount of one (1) year's due.

The procedure for application for associate membership is to complete the appropriate application and send it to the association office. The application will be reviewed by the Executive Vice President and be submitted to the Board of Directors for approval at its next scheduled meeting. Upon receipt of application and check for appropriate dues fee, the applicant will be placed on mailing list to receive all correspondence directed to members. Upon approval of application by the Board of Directors, the applicant will be notified and mailed a membership directory and an associate member recognition award.
